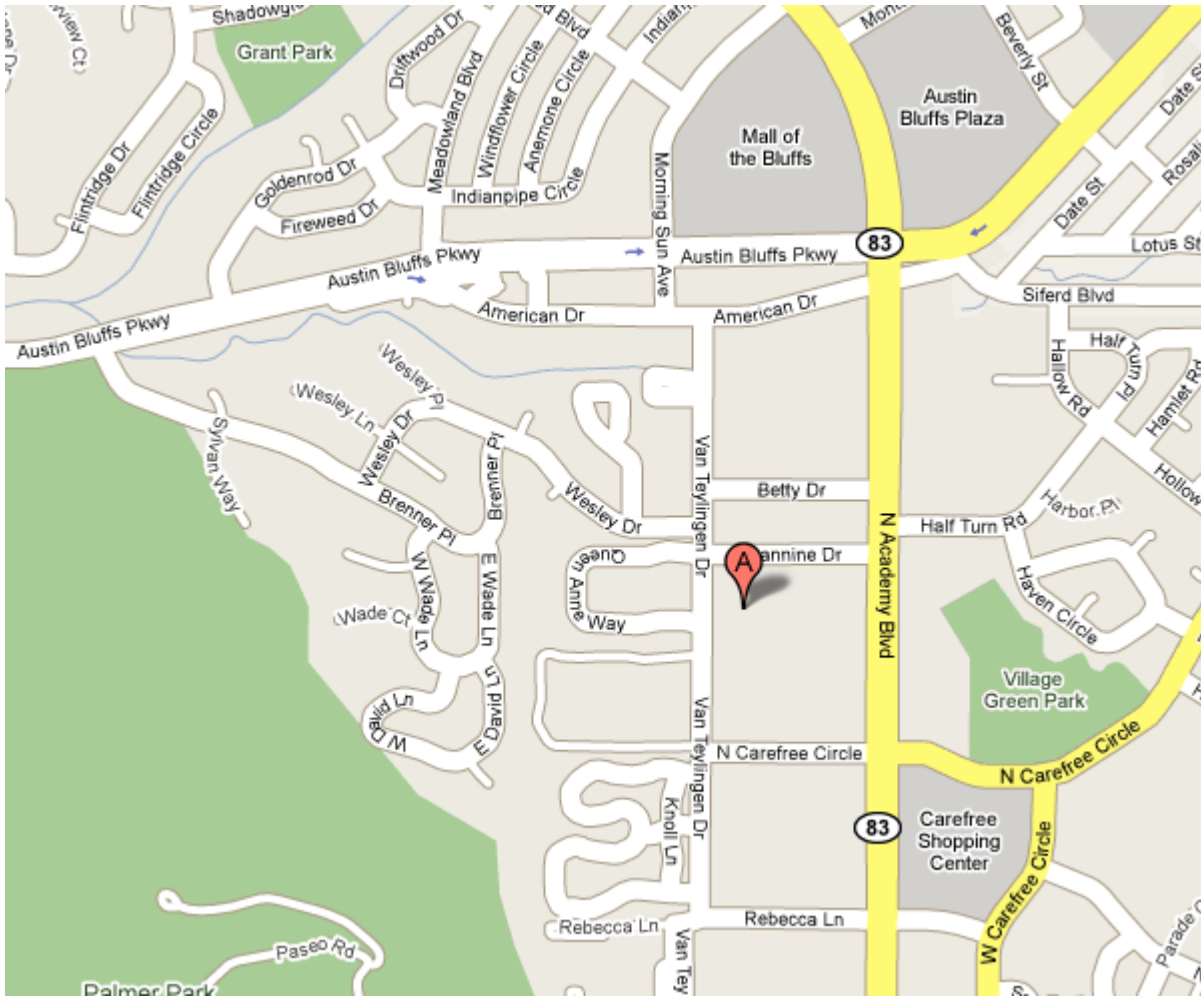

Turn LEFT onto Garden of the Gods. 0.4 miles

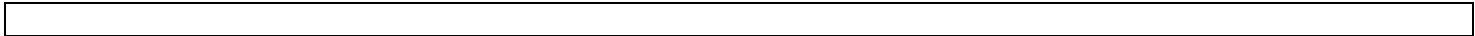
W GARDEN OF THE GODS RD becomes AUSTIN BLUFFS PKWY 3.4 miles
